

PROCEEDS OF CRIME (SUPERVISORY BODIES) (AMENDMENT OF LAW) (JERSEY) ORDER 2015

THE CHIEF MINISTER, in pursuance of Article 3(2) of the Proceeds of Crime (Supervisory Bodies) (Jersey) Law 2008¹, orders as follows –

1 Amendment of Article 3

In Article 3(1) of the Proceeds of Crime (Supervisory Bodies) (Jersey) Law 2008^2 , for sub-paragraphs (a), (b), (c), (ca), (d), (e), (f) and (g) there shall be substituted the following enactments –

"Proceeds of Crime (Jersey) Law 1999³;

Terrorism (Jersey) Law 2002⁴;

Money Laundering and Weapons Development (Directions) (Jersey) Law 2012⁵;

any Regulations or Order made under the Proceeds of Crime (Jersey) Law 1999, Terrorism (Jersey) Law 2002 or Money Laundering and Weapons Development (Directions) (Jersey) Law 2012;

Terrorist Asset-Freezing (Jersey) Law 2011⁶;

Al-Qa'ida and Taliban (United Nations Measures) (Channel Islands) Order 2002⁷;

Community Provisions (Wire Transfers) (Jersey) Regulations 2007⁸;

Community Provisions (Restrictive Measures – Lebanon) (Jersey) Order 2007⁹;

Community Provisions (Restrictive Measures – Zimbabwe) (No. 6) (Jersey) Order 2007¹⁰;
