Article 25(1)(a) of the States of Jersey Law 2005 permits the Chief Minister and Ministers to appoint one or more elected members as an Assistant Minster.

Article 25 (2) requires that a Minister may only appoint (or dismiss) an Assistant Minister with the prior consent of the Chief Minister.

The Chief Minister appointed the Connétable of St John and Deputy Alex Curtis of St Clement as Assistant Ministers to the Chief Minister.
