

## Political Oversight Group: Recovery from Major Incidents

# **Terms of Reference**

### Background and purpose

As is recommended practice in the wake of a critical incident, an operational Recovery Co-ordination Group (RCG) has been established to facilitate transition from the "Response Phase" to a "New Normality". As two major incidents occurred in the period before Christmas – Haut du Mont (Op. Spire) and the sinking of l'Ecume II (Op. Nectar) – the RCG is tasked to consider and support the Island's recovery from both. The RCG will place the deceased, affected family and friends, and displaced people at the heart of all decision making.

We anticipate that the full recovery phase will last many months, and potentially over a year.

A Political Oversight Group is proposed, to provide a clear formal connection between the operational RCG and the Council of Ministers.

#### Proposed role and responsibilities

- To inform the Recovery Impact Assessment, through elected members' close connection with their communities
- To oversee the recovery strategy and in due course the recovery action plan
- To ensure any necessary investigations or inquiries are identified and facilitated, and appropriate independence maintained
- To assist in the dissemination of credible information and advice back to the community, assisting to maintain community cohesion and providing public reassurance where needed
- To agree the strategy for obtaining views from the community (residents, businesses, etc) on longer-term recovery questions – e.g., memorial, future of the site – and taking the lead on behalf of the Council of Ministers on any States Assembly propositions or reports related to Op Spire and Op Nectar recovery
- To ensure clear, regular communication with the Council of Ministers, States Members, Parishes, Andium Homes, displaced residents and other key stakeholders (especially the families when decisions are made that affect them or the legacy of their loved ones)
- To monitor financial implications, ensuring all appropriate funding channels are explored and exploited appropriately and where costs are not covered by existing & approved budgets make recommendations for additional financial allocations to key recovery needs, as the recovery phase progresses

It is intended as a time-limited group that will close in tandem with the decision to close down the Recovery Coordination Group. No date is fixed at the current time.
