Chief Minister Ministerial Decision Report

NOMINATIONS TO THE JERSEY TEACHERS SUPERANNUATION FUNDS (JTSF) MANAGEMENT BOARD.

1. Purpose of the Report

1.1. To recommend to the Chief Minister the appointment of Mr James Bennett to the Management Board of the JTSF.

2. Background

- 2.1. The member who resigned from the Management Board was previously nominated by the National Association of Schoolmasters/Union of Women Teachers (NASUWT). People Services contacted NASUWT to request a further nomination to the Board to replace the member who resigned.
- 2.2. Once a person has been nominated by the respective union, the JTSF legislation requires approval from the Chief Minister to confirm the appointments. Article 3(1)(b) of the Teachers' Superannuation Fund (Administration) (Jersey) Order 2007 (Administration Orders) gives the power for the Chief Minister to appoint 6 members as employee representatives to the Management Board. Each appointment must have been nominated by an association that appear to the Minister for Children and Education to represent the interests of teachers.
- 2.3. Article 3(2) of the Administration Orders also requires that the members of the JTSF Management Board are only appointed for a period of 3 years, with all members the Management Board being automatically eligible for re-appointment.

3. Recruitment Process

- 3.1. The recruitment process was progressed in accordance with the Jersey Appointments Commission guidelines which only require the involvement of a member of the Commission for the appointment of the Chair.
- 3.2. The NASUWT contacted their membership outlining the role and requesting expressions of interest. The NASUWT received as expression of interest from Mr James Bennett and proceeded to confirm their nomination to People Services.
- 3.3. Article 3(1) provides that it is the decision of the Chief Minister to appoint member representatives who shall have been selected in the manner that the Chief Minister shall agree with associations that appear to the Minister for Children and Education to represent the interests of teachers. The member who resigned from the JTSF Management Board will be replaced by Mr James Bennett on the date of the Chief Minister's approval.
- 3.4. Details of the full JTSF Management Board following these appointments are shown at Appendix B.

4. Recommendation

4.1. For the Chief Minister to agree to appoint Mr James Bennett to the JTSF Management Board for a term of office of 3 years.

APPENDIX A

EMPLOYEE NOMINEE BACKGROUND

Mr James Bennett has dedicated his career to education and administration. Over the course of 25 years within CYPES (Children and Young People's Educational Service) Mr Bennett has held various roles at Grainville School included serving as a Teaching Assistant, Teacher, Head of Department, and a member of the Senior Leadership Team (SLT).

Mr Bennet moved from Grainville School to Highlands College 2 years ago, where he took up the role of Director of Admissions and Student Journey.

Mr Bennett's commitment to education extends beyond the classroom, as he has been actively involved in the NASUWT (National Association of Schoolmasters Union of Women Teachers) for over 15 years, contributing to the union's executive committee and served as the Membership Secretary for 8 years.
