## **TOURISM (GENERAL PROVISIONS) (AMENDMENT No. 16) (JERSEY) ORDER 2012**

*Made*

*Coming into force*

**THE MINISTER FOR ECONOMIC DEVELOPMENT**, in pursuance of Articles 6 and 32 of the Tourism (Jersey) Law 1948, orders as follows –

### **1 Interpretation**

In this Order, “principal Order” means the Tourism (General Provisions) (Jersey) Order 1990.

### **2 Article 1 amended**

In Article 1 of the principal Order, after the definition of “resident guest” the following definition shall be added –

“ ;

‘site of special interest’ has the same meaning as in Chapter 1 of Part 6 of the Planning and Building (Jersey) Law 2002.”.

### **3 Article 4 amended**

In Article 4 of the principal Order –

- (a) in paragraph (1)(g), for the words “Building Bye-Laws (Jersey) 2004” the words “Building Bye-laws (Jersey) 2007” shall be substituted;
- (b) in paragraph (1)(x), for the words “lighting and ventilation is satisfactory” the words “lighting and ventilation are satisfactory” shall be substituted;
- (c) for paragraph (2) the following paragraph shall be substituted –

“(2) The requirement set out in paragraph (1)(a)(ii) –

- (a) shall not apply to a previously registered hotel if, immediately before the appointed day, sleeping accommodation was provided in a separate building or

- buildings and the amount of accommodation so provided has not increased on or after the appointed day; or
- (b) may be waived by the Minister in respect of any premises in respect of which registration is sought if –
- (i) part of the sleeping accommodation on the premises is provided in one or more separate buildings,
- (ii) sub-paragraph (a) does not operate in respect of the premises, and
- (iii) the Minister is satisfied that the sleeping accommodation provided in the separate buildings offers standards of accommodation and comfort comparable to those of the sleeping accommodation provided elsewhere on the premises.”;
- (d) at the end of paragraph (3)(a) the word “and” shall be added;
- (e) in paragraph (5)(b), for the words “the premises are designated a site of special interest pursuant to Article 11 of the Island Planning (Jersey) Law 1964.” the words “the premises are a site of special interest.” shall be substituted.

#### 4 Article 6 amended

In Article 6 of the principal Order –

- (a) in paragraph (1)(g), for the words “Building Bye-Laws (Jersey) 2001” the words “Building Bye-laws (Jersey) 2007” shall be substituted;
- (b) in paragraph (1)(s), for the words “lighting and ventilation is satisfactory” the words “lighting and ventilation are satisfactory” shall be substituted;
- (c) for paragraph (2) the following paragraph shall be substituted –
- “(2) The requirement set out in paragraph (1)(a)(ii) –
- (a) shall not apply to a previously registered guest house if, immediately before the appointed day, sleeping accommodation was provided in a separate building or buildings and the amount of accommodation so provided has not increased on or after the appointed day; or
- (b) may be waived by the Minister in respect of any premises in respect of which registration is sought if –
- (i) part of the sleeping accommodation on the premises is provided in one or more separate buildings,
- (ii) sub-paragraph (a) does not operate in respect of the premises, and
- (iii) the Minister is satisfied that the sleeping accommodation provided in the separate buildings offers standards of accommodation and comfort comparable to those of the sleeping accommodation provided elsewhere on the premises.”;
- (d) at the end of paragraph (4)(a) the word “and” shall be added;

- (e) in paragraph (4)(b), for the words “the premises are designated a site of special interest pursuant to Article 11 of the Island Planning (Jersey) Law 1964.” the words “the premises are a site of special interest.” shall be substituted.

**5 Article 8 amended**

In Article 8 of the principal Order –

- (a) in paragraph (1)(k), for the words “Building Bye-Laws (Jersey) 2001” the words “Building Bye-laws (Jersey) 2007” shall be substituted;
- (b) in paragraph (2), for the words “the premises are designated a site of special interest pursuant to Article 11 of the Island Planning (Jersey) Law 1964.” the words “the premises are a site of special interest.” shall be substituted.

**6 Article 15 amended**

In Article 15(d) of the principal Order for the words “Building Bye-Laws (Jersey) 2001” the words “Building Bye-laws (Jersey) 2007” shall be substituted.

**7 Citation and commencement**

This Order may be cited as the Tourism (General Provisions) (Amendment No. 16) (Jersey) Order 2012 and shall come into force 7 days after it is made.
