Purpose of the Report

The purpose of this report is to consider those points raised in the representation (dated 02 May 2013) in relation to the Notice of Intent to List the above property that are not specifically related to heritage matters.

Discussion

The principal thrust of the objection appears to relate not to the heritage value of the site but that:

- the parish already recognises and cares for the cemetery;
- 'interference' from the States is unwelcome and unnecessary.

In response, the following issues are of relevance:

- Under the terms of the Convention for the Protection of the Architectural Heritage of Europe (1985), also known as the Granada Convention, the terms of which were extended to Jersey in 1988, the Minister is required to identify the Island's architectural heritage and to take statutory measures to protect it.
- The statutory duty on the part of the Minister in respect of buildings and places that could feature on the List of Sites of Special Interest (Listed buildings or places) is clear. Under Article 51(2) of the 2002 Law, once the Minister is satisfied of the public importance of a building or place by reason of any of the matters set out in that Article, he has to include it on the List.
- The site is already on the List of Sites of Special Interest: it was formally designated on 20 September 1999. It, therefore, already enjoys the full protection afforded to it by Part 6 of the Planning and Building (Jersey) Law 2002, and any change which affects the special interest of the site already requires the permission of the Minister. This matter is only under review as part of the comprehensive Island-wide review of heritage assets. The only proposed change to the heritage status of the site is the assignment of a non-statutory grade (@ G3).
- It is relevant to note that the extent of special interest relates to the gateway and boundary wall, as set out and described in the schedule.


