# Listed buildings and places La Maison du Mont au Pretre, La Route du Petit Clos, St Helier

#### Purpose of the Report

The purpose of this report is to respond to those issues raised in the representation received in response to the proposal to List this building that are not addressed by the material from Jersey Heritage.

#### Discussion

The nub of this representation (at appendix 1) is not the heritage interest of the building but rather the extent of the heritage interest relative to the award of planning permission for development here. The owner of the land is of the view that either the Listing should be delayed; or the boundaries of the extent of the site's interest should be revised now, to reflect the intent of implementing planning permission.

The facts of the case are as follows:

- The heritage assessment of this building (at appendix 2) has identified the house and the garden/open space associated with it, to the east and west, to be of heritage interest;
- A planning application to develop this and other land (P/2014/1334) has been awarded consent: if and when implemented, this will affect the land to the east of La Maison du Mont au Pretre, including part of the land embraced by the extent of this Listing (see approved site plan at appendix 3);
- The planning permission for this development has yet to commence (see aerial photo, dated Sept 2014, at appendix 4).

In light of the above, the representation is flawed on two counts;

First, this site already enjoys designation as a heritage asset (it is a potential Listed building, having been designated since 1992) and its value has been reviewed as part of the comprehensive Island-wide review to ensure that all historic buildings sit within the new historic environment protection regime: it is appropriately and timely that its heritage status is reviewed now.

Second, the fact that this site has planning permission cannot be material to the Minister's assessment of the site's heritage value as it exists now.

18. This position appears to me to be confirmed by Article 52(4)(a), which the Royal Court did not quote and mentioned only in passing. It requires the Minister to take into account any representations made by a person interested in a site "to the extent that they relate to the special interest of the proposed site of special interest". He is not obliged to take into account representations made by an interested person about any other matter. The adverse consequences of listing mentioned by the Royal Court, such as additional cost and planning difficulties, are consequences that will affect only persons interested in the listed site; but the

Minister need not take representations about them into account, because they do not relate to the special interest of the site. Since he need not take them into account, they cannot be material to his decision.

Minister for P&E v Seymour Villas Ltd [2013]JCA237

Planning permission, for whatever reason, might not be implemented and it is evident that the extent of the site's heritage value currently remains intact as assessed.

In the event that the development of the site proceeds, and impacts upon the extent of the interest of the site, it would be relevant to review the impact of development upon the site's heritage interest at that time.


It is our intention to commence work on the approved planning scheme, following which the boundaries to the new dwellings and the existing property will be re-defined.


