# Report - Jersey Police Authority: Appointment of Chair and Members

# The Jersey Police Authority (JPA)

The States of Jersey Police Force Law 2012 provides that there will be a Jersey Police Authority (JPA). The JPA are an independent body, and their main duties are to promote and support continuous improvement in the policing of Jersey; and to oversee the performance of policing services by the States Police Force.

Article 5(1) provides that the Authority shall consist of not less than 5 and not more than 7 members. It further provides that one of these members must be a Chairman, appointed by the Minister, and that there will be up to 4 members not being elected members of the States, who are appointed by the Minister and the Chairman.

## **Appointment of new Members**

Due to the term of office of the Chairperson ending in June 2023, and 2 vacancies for Members becoming available, a thorough search of the Jersey market for suitable candidates was undertaken to attract the best personnel for these roles.

The recruitment phase was open for 4 weeks and encompassed an extensive promotional campaign across various social media channels, including Linked In, Facebook and Twitter, as well as via the various members involved in organisations within the local community, the Law Society, and the JEP. Candidates were also invited to speak directly to a member of the JPA staff for an informal conversation about the role prior to applying of which several parties did, including Teams calls.

Further to this, it is recommended that the Minister appoints the following three individuals who have been successful with their applications. The term of the appointments is for 4 years, effective from the date the decision is signed.

### Simon Harman, for the position of the Chair

Simon's career began in the military serving for 8 years as an officer in the British Army before moving on and into the financial services.
