

ROAD RACING (MOTOR VEHICLE RALLY) (No. 2) (JERSEY) ORDER 2012

Made

Coming into force

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Article 2 of the Motor Vehicle Races (Jersey) (Law) 1946 and on the application of the Jersey Motor Cycle and Light Car Club, orders as follows –

1 General Provisions

- (1) This Order is subject to the Road Racing (General Provisions) (Jersey) Order 1959.
- (2) The promoters for the purposes of that Order and this Order, are the Jersey Motor Cycle and Light Car Club.

2 Use of roads for races with motor vehicles

- (1) The promoters may use a public road or part of a public road for races with motor vehicles on the courses described in Parts 1 to 9 of the Schedule, but may do so only on the date and between the hours specified in each Part of the Schedule in relation to that course.
- (2) For that purpose, the promoters may close a course to traffic on the date and between the hours so specified in relation to that course.

3 Provisions supplementary to use of Victoria Avenue course

- (1) The powers in this Article may be exercised for purposes incidental to the proper conduct of the races to be held on the course described in Part 1 of the Schedule.
- (2) On Thursday 11th October 2012 the promoters may
 - (a) between 7.00 a.m. and 7.00 p.m. close the lay-bys (and parking spaces) forming part of that course; and
 - (b) between 4.00 p.m. and midnight suspend the parking of vehicles on -

- (i) La Route de St. Aubin from the round-about at West Park to the traffic lights at the eastern side of the junction with the spur road at First Tower, and
- (ii) Gloucester Street between The Parade and The Esplanade.

4 Citation

This Order may be cited as the Road Racing (Motor Vehicle Rally) (No. 2) (Jersey) Order 2012.

SCHEDULE

A course comprising the following public roads and portions of public roads in the Parish of St. Helier –

The course to include the Public car park to the North of La Route du Nord and to the east of La Fontaine Tavern.
