TRIATHLON (JERSEY) ORDER 2013

Made

Coming into force

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Article 2 of the Entertainments on Public Roads (Jersey) Law 1985, on the application of 3D Performance Jersey and after consultation with the Connétables of St. Helier and St. Lawrence, orders as follows –

1 Interpretation

In this Order –

"entertainment" means the entertainment in the form of a swimming, cycling and running race known as the Jersey Triathlon;

"Law" means the Entertainments on Public Roads (Jersey) Law 1985;

"promoter" means 3D Performance Jersey.

2 Use of roads for entertainment

- (1) If the requirements as to insurance and public notice set out in Articles 7 and 8 are complied with, any public road (or part of a public road) specified in paragraphs (3), (4) and (5) may be used during the periods specified in paragraph (2) for the following purposes –
 - (a) the holding of the entertainment;
 - (b) the viewing of the entertainment;
 - (c) the making of arrangements preparatory to the holding and viewing of the entertainment.
- (2) The periods are
 - (a) in the case of the lay-by referred to in paragraph (3), the period between 6.00 p.m. on Saturday 29th June 2013 and 3.00 p.m. on Sunday 30th June 2013;
 - (b) in the case of the lay-bys referred to in paragraph (4)(a), the period between 8.00 a.m. and 3.00 p.m. on Sunday 30th June 2013;
 - (c) in the case of any other public road (or part of a public road) specified in paragraph (4), the period between 12 noon and 3.00 p.m. on Sunday 30th June 2013;

- (d) in the case of a public road (or part of a public road) specified in paragraph (5), the period between 12.45 p.m. and 4.15 p.m. on Sunday 30th June 2013.
- (3) The public road to which paragraph (2)(a) refers is the public lay-by lying first on the promenade on the seaward side of Victoria Avenue, when proceeding westward from West Park.
- (4) The public roads (or parts of public roads) to which paragraph (2)(b) and (2)(c) refer are the following
 - (a) the parking lay-bys lying fifth and seventh on the promenade on the seaward side of Victoria Avenue, when proceeding westward from West Park;
 - (b) Victoria Avenue, between Bel Royal and the Esplanade;
 - (c) Paris Lane;
 - (d) Tyneville Lane;
 - (e) the spur road that leads from Victoria Avenue into La Route de St. Aubin at First Tower;
 - (f) Farley's Lane;
 - (g) Rue du Galet;
 - (h) the beach in St. Aubin's Bay, between the western wall of Elizabeth Marina and La Haule slipway;
 - (i) the West Park slipway; and
 - (j) the promenade and the cycle path on the seaward side of Victoria Avenue between Bel Royal and La Haule slipway.
- (5) The public roads (or parts of public roads) to which paragraph (2)(d) refers are the following
 - (a) Esplanade from its junction with the exit from Esplanade car park to its junction with Castle Street;
 - (b) Payn Street;
 - (c) Sand Street from its junction with Payn Street to its junction with the slip road running between Seaton Place and Seale Street;
 - (d) Seaton Place from its junction with Payn Street to its junction with Seale Street;
 - (e) the slip road running between Seaton Place and Seale Street;
 - (f) Seale Street;
 - (g) York Street;
 - (h) Old Street;
 - (i) Union Street from its junction with Old Street to its junction with New Street;
 - (j) New Street from its junction with Union Street to its junction with King Street;
 - (k) Charing Cross;
 - (1) Broad Street, from its junction with Conway Street to Charing Cross;
 - (m) Castle Street;

- (n) the roundabout intersecting La Route du Port Elizabeth, Castle Street and La Route de la Liberation;
- (o) La Route du Port Elizabeth from its junction with La Route de la Liberation to the exit of the Waterfront car park;
- (p) Esplanade car park.

3 Road closures

- (1) During the period when a public road (or part of a public road) specified in Article 2(3), 2(4) or 2(5)(a) to (m) may be used for any of the purposes specified in Article 2(1), the promoter may cause it to be closed to traffic.
- (2) During the period when a public road (or part of a public road) specified in Article 2(5)(n) to (p) may be used for any of the purposes specified in Article 2(1), the promoter may cause the traffic flow to be stopped or otherwise controlled for such periods as are necessary to enable the safe passage through that road of any participant or spectator of the entertainment.

4 Closure of beach

Between 12 noon and 3.00 p.m. on Sunday 30th June 2013 the promoter may restrict or prohibit access to the area of the beach referred to in Article 2(4)(h) to all vehicular traffic, vehicles and members of the public.

5 Other arrangements for temporary regulation of traffic, safety of public, and purposes incidental to the entertainments

- (1) The powers in this Article may be exercised for purposes of or incidental to the entertainments.
- (2) Notwithstanding Article 4(2) of the Road Traffic (St. Lawrence) (Jersey) Order 1990 or Part 2 of Schedule 2 to that Order –
 - (a) between 12 noon and 3.00 p.m. on Sunday 30th June 2013, any vehicle may be driven from La Route de la Haule into La Route de St. Aubin; and
 - (b) between those times on that day, any vehicle may be driven from La Route de St. Aubin into La Route de la Haule.
- (3) Notwithstanding any other enactment, between 12 noon and 3.00 p.m. on 30th June 2013
 - (a) no vehicle shall remain on either side of La Route de St. Aubin between West Park roundabout and Bel Royal;
 - (b) no vehicle shall remain on either side of any public road (or part of a public road) that is specified in Article 2(3) or 2(4), except with the permission of the promoter, a police officer, or a person appointed by the promoter as an event marshal.
- (4) Between 12 noon and 3.00 p.m. on 30th June 2013 –

- (a) the promoter may close La Rue du Haut to traffic proceeding west from its junction with Le Mont Cambrai; and
- (b) the promoter may close to eastbound traffic the spur road that leads from La Route de St. Aubin to The Esplanade.
- (5) Between 12 noon and 3.00 p.m. on 30th June 2013, the promoter may close
 - (a) La Rue de la Ville Emphrie to eastbound traffic; and
 - (b) St. Peter's Valley, between Bel Royal and the junction with La Rue du Haut, to southbound traffic other than omnibuses and large goods vehicles.
- (6) Notwithstanding Article 3(1) of the Road Traffic (St. Helier) (Jersey) Order 1996 or Part 1 of Schedule 1 to that Order, between 11.45 a.m. and 4.15 p.m. on Sunday 30th June 2013 any vehicle may be driven in either direction on the following roads or parts of roads –
 - (a) Commercial Street;
 - (b) Devonshire Place from its junction with Lemprière Street to its junction with Great Union Road;
 - (c) Le Geyt Street;
 - (d) Lemprière Street.
- (7) Notwithstanding any other enactment, between 11.45 a.m. and 4.15 p.m. on Sunday 30th June 2013, no vehicle shall remain on either side of any public road (or part of a public road) that is specified in Article 2(5), except with the permission of the promoter, a police officer, or a person appointed by the promoter as an event marshal.
- (8) In paragraph (5) "omnibus" has the same meaning as in the Motor Traffic (Jersey) Law 1935 and "large goods vehicle" has the same meaning as in the Road Traffic (Jersey) Law 1956.

6 Material required for entertainment

During the period when a public road (or part of a public road) specified in Article 2(3), (2)(4) or 2(5) may be used for any of the purposes specified in Article 2(1), the promoter may cause to be placed on the road (or part) material required for the purposes of or in connection with the entertainment.

7 Insurance cover

The requirements of this Article to which Article 2(1) refers are that the promoter must produce to the Minister, not later than Friday 21st June 2013, evidence that there is insurance (to the satisfaction of the Minister) against any liability that may be incurred by –

- (a) any person organizing, supervising, or concerned in the conduct of, the entertainment;
- (b) the promoter;
- (c) any official, agent or servant of the promoter;

(d) any person taking part in the entertainment,

in respect of damage to property, or in respect of the death of any person or bodily injury to any person, resulting from the holding or viewing of the entertainment or from any of the preparations for the entertainment.

8 Public notice of restrictions

- (1) The requirements of this Article to which Article 2(1) refers are as set out in paragraphs (2) and (3).
- (2) On 2 occasions during the 9 days immediately preceding Sunday 30th June 2013, the promoter must cause to be published in the Jersey Gazette a notice of
 - (a) each proposed closure, under Article 3 and 4, of a public road; and
 - (b) each arrangement that will apply under Article 5,

specifying the roads and periods concerned.

(3) Each notice is to be certified by the Greffier of the States as a notice that is being published in pursuance of this Order.

9 Limited access

- (1) Nothing in this Order prevents a pedestrian from using a footpath adjacent to a public road (or part of a public road) that is closed under this Order.
- (2) However, a pedestrian must not cross any public road (or part of a public road) when it is closed under this Order unless the pedestrian does so at a point, and at a time, designated by the promoter, a police officer, or a person appointed by the promoter as an event marshal.
- (3) Despite this Order, a police officer, or a person appointed by the promoter as an event marshal, may allow such access as is reasonably required for vehicles to any premises that are situated on or adjacent to any public road (or part of a public road) that is closed under this Order.

10 Citation

This Order may be cited as the Triathlon (Jersey) Order 2013.
