JERSEY FESTIVAL OF CYCLING (JERSEY) ORDER 2014

Made

Coming into force

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Article 2 of the Entertainments on Public Roads (Jersey) Law 1985, and after consultation with the Connétables of Grouville, St. Martin and St. Saviour, orders as follows –

1 Interpretation

In this Order –

"closed", unless otherwise indicated, means closed to vehicle traffic;

"event" means one of the cycling races, time trials or similar events forming part of the Jersey Festival of Cycling, and includes any related practice or preparatory activity;

"Jersey Festival of Cycling" means the whole of the series of events and related entertainments taking place as further described in Article 5 and the Schedule;

"Minister", unless otherwise indicated, means the Minister for Transport and Technical Services.

2 Promoter and exercise of promoter's powers

- (1) For the purposes of this Order, the promoter is Jersey Tourism.
- (2) The powers conferred on the promoter by Article 5 may be exercised only if the requirements in Articles 3 and 4 (as to insurance and public notice respectively) are fulfilled.

3 Requirement as to insurance

The requirement as to insurance mentioned in Article 2 is that the Minister must be satisfied that there is in place sufficient insurance against any liability that may be incurred by -

- (a) any person organizing, supervising, or concerned in the conduct of, the Jersey Festival of Cycling;
- (b) the Minister for Economic Development;
- (c) any official, agent, or servant of the Minister for Economic Development; and
- (d) any person taking part in the Jersey Festival of Cycling,

in respect of damage to property, or in respect of the death of or bodily injury to any person resulting from anything done by the promoter for the purposes listed in Article 5(1)(a) to (c).

4 Requirement as to public notice

The requirement as to public notice mentioned in Article 2 is that on 2 occasions during the 10 days immediately preceding Friday 13th June 2014, the promoter must cause to be published in the Jersey Gazette notice -

- (a) of each proposed closure of a course road under Article 5;
- (b) of each proposed arrangement under Article 6;

and such notice shall be certified on each such occasion by the Greffier of the States as notice that is being published in pursuance of this Order.

5 Roads to be used for Jersey Festival of Cycling

- (1) A public road or location named in the first column of the Schedule and (as to part of a public road) further specified in the second and third columns of the Schedule (a "course road") may be closed by the Minister or the promoter and may be used, on the dates and during the periods specified in the fourth column of the Schedule, by the promoter for the purposes of –
 - (a) holding the Jersey Festival of Cycling;
 - (b) public viewing of the Jersey Festival of Cycling; and
 - (c) making arrangements preparatory or incidental to the holding and viewing of the Jersey Festival of Cycling.
- (2) Between 9.00 a.m. on Friday 13th June and 10.00 p.m. on Sunday 15th June, the promoter may (in particular and without derogation to the generality of the power in paragraph (1)) place and maintain any material required for the purposes of or in connection with the Jersey Festival of Cycling
 - (a) on, above or beside any course road; and
 - (b) on such part of the Beach Road car park in Gorey, or of the Gorey Common car park in Gorey, as the promoter may reasonably require.
- (3) Between 9.00 a.m. on Saturday 14th June and 10.00 p.m. on Sunday 15th June the promoter may close Gorey Pier from its junction with Le Mont de Gouray and Le Mont Gabard to the Crane, for the purpose of providing refreshments and entertainments for and in connection with the Jersey Festival of Cycling.

6 Arrangements relating to access, parking restrictions etc.

- (1) Notwithstanding Article 3 of the Road Traffic (Grouville) (Jersey) Order 2002 or Schedule 1 to that Order, between 9.00 a.m. and 10.00 p.m. on Friday 13th June and between 6.00 a.m. and 10.00 p.m. on Sunday 15th June, any vehicle may be driven in either direction along any of the following roads, or parts of roads, for the purpose of ingress to or egress from any property in that road –
 - (a) the part of La Rue à Don known as Beach Road;
 - (b) Gorey Village Road between the bottom of La Chèvre Rue (Daisy Hill) and Beach Road;
 - (c) Old Road;
 - (d) Union Road.
- (2) Notwithstanding the Road Traffic (Grouville) (Jersey) Order 2002, the Road Traffic (St. Martin) (Jersey) Order 1989 or the Road Traffic (St. Saviour) (Jersey) Order 2000, no vehicle shall remain on any course road between 8.00 a.m. on Friday 13th June and 10.00 p.m. on Sunday 15th June, nor remain (without derogation from that general prohibition) –
 - (a) on Gorey Village Main Road from La Rue Horman to La Mont de Gouray, between 8.00 a.m. on Friday 13th June and 10.00 p.m. on Sunday 15th June;
 - (b) on Gorey Pier from La Petite Ruelle Muchie to the Coach Park area, between 8.00 p.m. on Thursday 12th June and 10.00 p.m. on Sunday 15th June;
 - (c) on Gorey Coast Road, between 8.00 p.m. on Thursday 12th June and 10.00 p.m. on Sunday 15th June;
 - (d) on Le Mont de Gouray from Gorey Village Main Road to La Route de la Côte, between 8.00 a.m. on Friday 13th June to 1.00 p.m. on Sunday 15th June;
 - (e) on La Route de la Côte from Le Mont de Gouray to Le Mont de la Guerande, between 10.00 a.m. on Friday 13th June to 1.00 p.m. on Sunday 15th June;
 - (f) on New Road and Old Road, between 8.00 a.m. and 10 p.m. on Friday 13th June;
 - (g) on La Rue de la Ville ès Renards (including the area around the War Memorial) from La Rue des Près to La Rue à Don, between 7 a.m. and 1.00 p.m. on Sunday 15th June.
- (3) Notwithstanding the Road Traffic (Public Parking Places) (Jersey) Order 2006, no vehicle shall remain in any part of the Beach Road car park in Gorey between 9.00 a.m. on Friday 13th June and 10.00 p.m. on Sunday 15th June.

7 Course management in interests of public safety

(1) Subject to paragraph (2), nothing in this Order prevents a pedestrian from using a footpath adjacent to a course road.

- (2) A pedestrian must not cross a course road which is closed under this Order unless the pedestrian does so at a point and at a time designated for the purpose by the promoter, a police officer or a person appointed by the promoter as a marshal (an "event marshal").
- (3) A police officer or an event marshal may allow such access as is reasonably required for a vehicle to any property situated on or adjacent to a course road which is closed under this Order.
- (4) A police officer or an event marshal may prohibit, restrict, regulate or allow the access of persons (whether with a vehicle or otherwise) onto, along or across a course road which is closed under this Order if and to the extent that the officer or marshal considers it necessary to do so in the interest of public safety.
- (5) A member of the Fire and Rescue Service, Ambulance Service, Jersey Coastguard, Royal National Lifeboat Institution, or a police officer may (whether with a vehicle or otherwise) enter and use any part of a course road which is closed under this Order if and to the extent that it is reasonably necessary to do so for the purposes of that member's or officer's duty.

8 Ferry passengers

Nothing in this Order shall authorize the restriction of such access as is reasonably required by a pedestrian who wishes to get on or off a ferry at Gorey as a foot passenger.

9 Citation

This Order may be cited as the Jersey Festival of Cycling (Jersey) Order 2014.
