ROAD TRAFFIC (TRINITY) (AMENDMENT No. 8) (JERSEY) ORDER 2014

Made

Coming into force

THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES, in pursuance of Articles 62 and 84 of the Road Traffic (Jersey) Law 1956, and after consultation with the Connétable of Trinity, orders as follows –

1 Interpretation

In this Order “principal Order” means the Road Traffic (Trinity) (Jersey) Order 1988.

2 Article 4A substituted

For Article 4A of the principal Order there shall be substituted the following Article –

“4A Restriction on parking of vehicles on certain roads

- (1) No vehicle that is parked on a road specified in Part 1 of Schedule 3 shall be parked for a total period exceeding 12 hours in any continuous period of 24 hours.
- (2) No vehicle that is parked on a road specified in Part 2 of Schedule 3 shall be parked for longer than 20 minutes.
- (3) A vehicle parked on a road specified in Part 2 of Schedule 3 must not park in any part of the same road within one hour after the expiry of the period permitted under paragraph (2).
- (4) When a vehicle is parked on a road specified in Part 2 of Schedule 3 a parking disc conforming generally with the conditions in paragraph (5) and indicating the time at which the vehicle arrived there must be displayed –
 - (a) against the internal face of the windscreen of the vehicle; or
 - (b) if the vehicle has no windscreen, at a convenient place on the left or near side of the vehicle, in such manner that the

time of arrival of the vehicle may be distinctly seen by any person outside the vehicle.

- (5) The conditions referred to in paragraph (4) are that –
- (a) the disc shall be composed of 2 pieces of pale yellow cardboard enclosing 3 red cardboard discs each pivoted about its centre on which shall be printed figures which shall be revealed through 3 apertures cut into one of the pieces of yellow cardboard; and
 - (b) the left hand aperture shall reveal the hour, the centre aperture the tens of minutes, and the right hand aperture the minutes, of the time of arrival at the parking place.
- (6) A person must not –
- (a) display more than one parking disc on the vehicle;
 - (b) indicate on the parking disc a time different from that of the time of arrival at the parking place;
 - (c) alter the time of arrival indicated on the parking disc whilst the vehicle is parked on that road;
 - (d) alter the time of arrival indicated on the parking disc whilst the vehicle is parked on any part of that road during the period permitted under paragraph (2).”.

3 Schedule 2 amended

In Schedule 2 to the principal Order, in the entry relating to Les Charrières du Boulay –

- (a) for the words “East side (from the public toilets at the bottom of the hill to a point opposite the western gable of the property known as ‘Undercliff Guest House’).” there shall be substituted the words “East side from the public toilets at the bottom of the hill to a point 12 yards west of the western gable of the property known as ‘Undercliff Guest House’.”;
- (b) for the words “South and east side (from a point 50 yards south of its junction with La Vielle Charriere to a point 100 yards east of that junction).” there shall be substituted the words “South and east side (from a point 50 yards south of its junction with La Vielle Charriere to a point 106 yards east of that junction).”.

4 Schedule 3 substituted

For Schedule 3 to the principal Order there shall be substituted the following Schedule –

“SCHEDULE 3

(Article 4A)

DURATION OF PARKING ON CERTAIN ROADS

PART 1

PARKING LIMITED TO 12 HOURS IN 24 HOURS

Les Charrières du Boulay

West and north side (from the public toilets at the bottom of the hill to a point 25 yards to the east of the northern entrance to the property known as ‘North Cove’).

PART 2

PARKING LIMITED TO 20 MINUTES WITH DISC

La Rue ès Picots

South side, from a point 10 yards east of the junction with Rue du Câtel to a point 21 yards further east.

South side, from a point 10 yards west of the junction with Rue du Câtel and a point 17 yards further west.”.

5 Citation and commencement

This Order may be cited as the Road Traffic (Trinity) (Amendment No. 8) (Jersey) Order 2014 and shall come into force 7 days after it has been made.
