## GOREY FÊTE (JERSEY) ORDER 2015

*Made**Coming into force*

**THE MINISTER FOR TRANSPORT AND TECHNICAL SERVICES**, in pursuance of Article 2 of the Entertainments on Public Roads (Jersey) Law 1985, on the application of the Gorey Fête Committee, and after consultation with the Connétables of St. Martin and Grouville, orders as follows –

### **1 Gorey Fête**

- (1) If the Gorey Fête Committee complies with the requirements as to insurance cover and public notice in Articles 2 and 3, it may use the parts of public roads set out in paragraph (2) for the purpose of holding an entertainment by way of the fête known as the Gorey Fête, on Thursday 20th August 2015.
- (2) The parts of public roads mentioned in paragraph (1) (collectively, “the site”) are –
  - (a) Gorey Pier from its junction with Gorey Coast Road (A3) to the crane;
  - (b) Gorey Coast Road (A3) from a point parallel to the point on Le Mont de Gouray that is midway between the shop known as “Jane James” and the former café to the east of the public car parking area, to the western end of the coach parking area; and
  - (c) the coach parking area.

### **2 Insurance cover**

The requirement as to insurance cover mentioned in Article 1(1) is that, no later than Friday 7th August 2015, the Gorey Fête Committee must produce to the Minister for Transport and Technical Services satisfactory evidence that the Committee is covered by insurance, in the manner and to the extent that the Minister may require, against any liability which may be incurred by –

- (a) the Committee;
- (b) any official, agent or servant of the Committee; or
- (c) any person taking part in the fête,

in respect of damage to property, the death of any person, or bodily injury to any person, resulting from the holding of the fête.

### **3 Public notice of restrictions on traffic**

- (1) The requirement as to public notice mentioned in Article 1(1) is that on 2 occasions during the 5 days immediately preceding Tuesday 18th August 2015, the Gorey Fête Committee must publish in the Jersey Gazette a notice of its intention under Article 4 to close the site and the parking areas on it to traffic –
- (2) The notice under paragraph (1) must specify –
  - (a) the dates on which and the times between which the closures mentioned in paragraph (1) are to occur; and
  - (b) the details of any prohibitions that the Committee intend to impose under Article 5.
- (3) The notice under paragraph (1) must be certified by the Greffier of the States as a notice being published under this Order.

### **4 Closure of site**

- (1) The Gorey Fête Committee may, for the purposes of or in connection with the holding of the fête, close to traffic –
  - (a) the site between 10 a.m. on Wednesday 19th August 2015 and 10 a.m. on Friday 21st August 2015;
  - (b) parking areas within the site, between 12 noon on Tuesday 18th August 2015 and 12 noon on Friday 21st August 2015.
- (2) During the period of closure of the site under paragraph (1), the Committee may –
  - (a) place and maintain on any part of the site anything required for the purposes of or in connection with the holding of the fête;
  - (b) restrict or prohibit the parking of vehicles on the whole or any part of the site; and
  - (c) (in particular but without limiting sub-paragraph (a)) place and maintain on any part of the site that is the carriageway of a road any decorative features required for the purposes of or in connection with the holding of the fête.

### **5 Other traffic restrictions**

- (1) The Gorey Fête Committee may –
  - (a) require vehicles being driven on any part of Beach Road that is not a one-way traffic route under Schedule 1 to the Road Traffic (Grouville) (Jersey) Order 2002, to travel in the direction of Gorey Village Road only;
  - (b) prohibit the driving of vehicles –
    - (i) along Le Mont de Gouray in the direction of Gorey Village Road,

- (ii) along La Rue à Don from Beach Road to Gorey Coast Road (A3), and all of Gorey Coast Road, in the direction of Gorey Pier,
- (iii) along La Route le Brun, La Route de la Côte and La Route d'Anne Port from Le Mont de la Mare Ste. Catherine in the direction of Les Charrières d'Anne Port, and
- (iv) along La Route de la Côte from Les Charrières d'Anne Port in the direction of Le Mont de Gouray,

between 10 a.m. on Wednesday 19th August 2015 and 12 noon on Friday 21st August 2015.

- (2) The Gorey Fête Committee may prohibit the driving of vehicles on any part of Gorey Pier that is part of the site, between 8 a.m. on Wednesday 19th August 2015 and the start of the closure of that part under Article 4(1).
- (3) Despite any other enactment vehicles must not remain on –
  - (a) Gorey Coast Road from Gorey Village Slip to Gorey Pier; and
  - (b) Le Mont de Gouray from Gorey Pier to its junction with La Route de la Cote,

between 12 noon on Wednesday 19th August 2015 and 9 a.m. on Friday 21st August 2015.

## **6 Admission fees**

The Gorey Fête Committee may make reasonable charges for the admission of spectators to the fête.

## **7 Access to premises and ferry**

- (1) Nothing in this Order authorizes the restriction of such access as is reasonably required –
  - (a) for vehicles to any premises situated on or adjacent to the site; or
  - (b) by a pedestrian who wishes to get on or off a ferry at Gorey as a foot passenger.
- (2) Despite paragraph (1)(a), a police officer or a member of the Gorey Fête Committee may prohibit, restrict or regulate vehicular traffic in any way that the officer or member considers necessary in the interest of public safety.

**8 Citation**

This Order may be cited as the Gorey Fête (Jersey) Order 2015.
