Introduction

A request has been received from Infrastructure, Housing and Environment for the temporary closure of Midvale Road Car Park while Midvale Road is resurfaced as part of the Public realm improvement scheme works.

Recommendation

Select recommendation. The Minister is recommended to approve the temporary closure of Midvale Road Car Park on Thursday 5th May 2022 9.30am to 2.30pm (date is weather dependant)

Detail

Infrastructure, Housing and Environment are currently replacing footways and resurfacing Midvale Road and on Thursday 5th May the area in front of the Public Car Park is due to be resurfaced. Various options have been discussed but the purpose for the closure is it will enable IHE to remove a joint in the surface course at the entrance to the car park which will be a highly stressed area post-construction.

We have chosen the hours of 9.30am to 2.30pm as traffic movement is very limit during this period and parents will be able to leave regarding school runs.

Communication Plan

:1) Consultation with the Parish of St Helier.

2) Letter drop all residents within the local vicinity.

3) Advance signs installed at car park 1 week before on Thursday 28th April.

4) Social Media posts notifying the public.

5) Update roadworks website.

6) A banksman will be at the car park entrance for 2 hours on Wednesday 4th May (4pm to 6pm) and for 2 hours on Thursday 5th May (7.30am to 9.30am). The banksman will inform all the car park users of the closure.

The Road Traffic (Public Parking Places) (Jersey) Order 2006 is administered by the Minister for Infrastructure.

Article 3 (c) of the Road Traffic (Public Parking Places) (Jersey) Order 2006 allows the controlling body of a parking place to close for any period and for any purpose the whole or any part of a parking place by notice displayed at the parking place.
