## 1 Introduction

A request has been received from Steve Salmon who is responsible for facilitating the Jersey International Motoring Festival event for the temporary closure of Laybys 1 & 4 car parks on Victoria Avenue. Layby1 between 2pm and midnight Friday 3rd June and Layby4 between 8am and midnight Friday 3rd June 2022

## Recommendation

The Minister is recommended to approve the temporary closure of Laybys 1 & 4 car parks on Victoria Avenue to allow the Jersey International Motoring Festival to take place.

## Detail

This Event has become very well established, and the car park closures requested are the same as in previous years and enabled Jersey to receive widespread international publicity through various media. The event attracts competitors from several different countries and promotes the Island as a good venue for similar events and as a tourism destination. The car park has always been returned in a clean and tidy state.

Infrastructure, Housing and Environment have issued an Events license and Bailiffs permission has also been approved.

#### **Reason for Decision**

Article 3 (c) of the Road Traffic (Public Parking Places) (Jersey) Order 2006 allows the controlling body of a parking place to close for any period and for any purpose the whole or any part of a parking place by notice displayed at the parking place.

The Road Traffic (Public Parking Places) (Jersey) Order 2006 is created in pursuance of Articles 59 and 84 of the Road Traffic (Jersey) Law 1956.

The Road Traffic (Public Parking Places) (Jersey) Order 2006 is administered by the Minister for Infrastructure.
