Introduction

The Minister for Infrastructure is asked to approve the issuance of Legislative Drafting Instructions for an Amendment to the Road Traffic (St. Helier) (Jersey) Order 1996 to include a number of Article 68 Notices previously published and to include changes requested by the Connétable of St. Helier.

Recommendation

Detail

During 2022 a number of Article 68 Notices were published to make changes to the Road Traffic (St. Helier) (Jersey) Order 1996 which now require to be formalised by adding them to the Order

There have also been a number of requests for changes received from the Connétable of St. Helier, all of which are detailed below, for inclusion in the Order.

Resident's Parking Permits – Fees

The Parish of St Helier have requested an increase to the fees charged for the various Resident's Parking Permits be included in the Amendment as below:

Article 32 – Fees for Permits

- Amend the entry in Article 32 (1) (a) (i) from the current £326.81 to £401.15;
- Amend the entry in Article 32 (1) (a) (ii) from the current £162.37 to £199.98;
- Amend the entry in Article 32 (1) (b) from the current £242.80 to £295.84;
- Amend the entry in Article 32 (2) to read: If a permit is to be in force for less than 12 months, the fee payable shall be £10.00 for each day for which the permit is to be in force.

Schedule 1 (One-Way Traffic)

- Part 1 One -way Traffic Routes
 - After the entry for Bond Street insert ('Brighton Lane' in the first column and 'Brighton Road to Rouge Bouillon in the second column')
- Part 3 Exemptions
 - After the entry for Charing Cross insert ('Esplanade (between Weighbridge Place and Conway Street' in the first column and 'Omnibuses' in the second column)

Schedule 4 (Prohibition of Waiting)

 Amend the existing entry for Parade, The (Eastern Arm) in column 2 to read: 'East Side (between its junction with Union Street and a point 44 yards further north)'

Schedule 5 (Roads closed to through traffic)



 After the existing entry for Old Don Road add a new entry in the first column 'Old St Johns Road' and in the second column 'All times'

<u>Schedule 6 (Pedestrian Roads – closing to, and restricted use by, vehicular traffic)</u>

- Part 1 Roads closed to vehicular traffic
 - After the entry for Bath Street add a new entry in the first column 'Brighton Lane' and in the second column 'At all times';
 - o Remove the existing entry for 'Charing Cross' in columns 1 and 2;
 - o Remove the existing entry for 'Esplanade' in columns 1 and 2;
- Part 3 Exemptions
 - Before the entry for Broad Street add a new entry in the first column 'Brighton Lane' and in the second column 'Pedal cycles';
 - Remove the entry for 'Esplanade' in the first column and 'Omnibuses' in the second column;

Schedule 8 - Paying Parking Places

- Part 2 1 hour limit
 - Amend the existing entry for 'Parade, the (Eastern Arm) in the second column to read 'West side (between a point 51 yards north of its junction with Union Street and a point 61 yards further north)';

Schedule 10 - Parking of vehicles on roads for loading and unloading

- Part 1
 - Remove the existing entry for Bath Street in columns 1 to 4;
 - After the entry for Hilgrove Street add a new entry in the first column 'Hill Street', in the second column 'North side (between a point 35 yards west of its junction with La Motte Street and a point 15 yards further west)', in the third column '20 minutes' and in the fourth column '5am to 6pm Monday to Saturday';

Schedule 11 - Parking of Motorcycles and Mopeds

- o Remove the existing entry for 'The Parade' from columns 1 and 2;
- After the entry for 'Parade Road' add a new entry in the first column 'Parade,
 The (Eastern Arm)' and in the second column 'Western side (between a point
 29 yards north of its junction with Union Street and a point 9 yards further
 north)';
- Add a second entry in the second column for 'Parade, The (Eastern Arm)' –
 'Western side (between a point 45 yards north if its junction with Union Street and a point 6 yards further north)'.
