### Introduction

The Minister for Infrastructure is asked to approve the issuance of Legislative Drafting Instructions for an Amendment to the Road Traffic (St. Helier) (Jersey) Order 1996 to increase the charges for Resident Parking Permits as requested by the Connétable of St. Helier.

### Recommendation

To request the Principal Legislative Drafter to draft the necessary legislation.

### Detail

A request had been received from the Connétable of St. Helier to increase the cost of permits issued by the Parish for use in the Residents Parking Permit areas.

The Parish of St. Helier administer and police the Resident Permit scheme and keep all the income, which covers their costs. Costs are reviewed on an annual basis by the Parish.

#### Article 32 – Fees for Permits

- Amend the entry in Article 32 (1) (b) from the current £242.80 to £295.84;
