### **Introduction**

The Minister for Infrastructure is asked to approve changes to the Road Traffic (St Saviour) (Jersey) Order 2000 to make changes to parking on Bagatelle Road, La Chasse Brunet and La Rue du Trot and the Road Traffic (Disabled Persons) (Parking) (Jersey) Order 2002 to introduce a new disabled parking space outside St Saviours School on La Chasse Brunet in pursuance of Article 68 Road Traffic (Jersey) Law 1956 and after consultation with the Connétable of St Saviour.

### **Recommendation**

### **Detail**

The Connétable of St. Saviour has requested a change to parking outside St Saviours School on Bagatelle Road to improve availability of spaces for use by adults wishing to drop off or collect children from the school. Currently there is no restriction on use of the parking area and often people trying to drop children off at the school are unable to find a safe space to be able to do this. The introduction of a new 1 hour maximum stay period between 7am and 6pm Monday to Saturday in this area will assist in providing a good turnover of parking outside the school. (Appendix 1)

A new disabled parking bay has also been requested on La Chasse Brunet, close to the rear entrance of the school which be of assistance to people dropping off children who have disabilities safely by an accessible entrance to the school. It is understood there are currently 4 children with disabilities at the school who will benefit from this new disabled parking space. A maximum stay of 30 minutes has been requested to try and provide a turnover of vehicles using this space. (Appendix 1)

An extension to an existing prohibition of waiting area on Bagatelle Road by the junction with Patier Road has also been requested to improve visibility and road safety and this is supported by the Road Safety Review Panel. (Appendix 1)

A further area of concern on La Rue du Trot has been reported to the Department at one of the access points to the property known as "Southfork". Parts of this are used by a large builders merchant who have numerous large HGV vehicles exiting to deliver to building sites throughout the Island and their egress is made difficult by the parking of a number of vehicles adjacent to the exit used. The introduction of a new area of prohibition of waiting will remove this obstacle and improve safety for all road users in this area. The new prohibition of waiting will extend beyond the junction with La Rue de Sergent which is an area identified by the Parish as being problematic and difficult to police. (Appendix 2)

The Minister is asked to approve these changes in pursuance of Article 68 of the Road Traffic (Jersey) Law 1956, and after consultation with the Conétable, so they can be implemented before the start of the new school term. Their impact will be monitored with any required changes made prior to the formalising of these by Amendment to the Road Traffic (St Saviour) (Jersey) Order 2000.

Policing of these areas is undertaken by the Parish Honorary Police and parking warden.

The Road Traffic (St Saviour) (Jersey) Order 2000 and the Road Traffic (Disabled Persons) (Parking) (Jersey) Order 2002 are administered by the Department for Infrastructure.

**Road Traffic (St Saviour) (Jersey) Order 2000**

**Article 7A – Parking of Vehicles displaying parking discs etc Limit on Parking**

Amend Article 7A (1) (b)(ib) to add a new 1 hour parking limit between 7am and 6pm Monday to Saturday with a requirement to display an arrival time using a parking disc (yellow time clock)

Introduced to the articles of the order: -

**7A Parking of Vehicles displaying parking discs etc.**

(1)(b)(ib) In in Part 1A of Schedule 6, at any time other than for a period not exceeding 1 hour between the hours of 7.00 a.m. and 6.00 p.m., or

Introduced to the schedule of the order: -

**Schedule 3 - Part 1 – Prohibition of waiting**

- Add to the existing entry for Bagatelle Road – in column 2 “North side, from the junction with La Rue de Patier for a distance of 30 yards in a southerly direction”
- Add a new entry in Column 1 after the entry for La Chasse Brunet “La Rue du Trot” and in Column 2 “East side from a point 10 yards north of the junction with La Rue de Sergent for to a point 68 yards south of the junction”

**Schedule 6 – Part 1B**

Add a new part for disc parking 1 hour duration in accordance with the new addition to Article 7A (1) (b)(ib) as above

- Add to Column 1 “Bagatelle Road” and in Column 2 “North Side from a point 230 yards south of the junction with La Rue de Patier for a distance of 123 yards in a southerly direction”
