#### Introduction

The report outlines the current arrangements for the IE Eco-Permit parking scheme and the requirement to introduce a legal expiry date to the benefits of the scheme.

#### **Background**

The original Eco-Permit parking scheme was launched in 2008, allowing cars with low carbon emissions to take advantage of half price Paycard parking. There have since been a number of changes which reduced the maximum emission levels following trends within the motor industry to produce more efficient engines.

The 'Parking Places) (Jersey) Order 2006' which set out prescribed parking and season ticket charges, provides the legal basis for the Eco-Permit Scheme. As such:

- Any fully electric or plug in hybrid electric vehicle (PHEV) with emissions of 50 gram CO2
  per kilometre travelled or less currently qualifies for the scheme and receive half price
  parking in Government of Jersey car parks and chargeable on street locations in St
  Helier.
- Additionally, EVs and PHEVs 'new to Jersey' (including second hand vehicles from other jurisdictions), meeting the emissions limits outlined above qualify for free parking in Government of Jersey car parks during the first year that the vehicle is registered in Jersey.

The Eco-Permit scheme supports The Carbon Neutral Roadmap's 'TR1 – Speeding up adoption of electric vehicles', policy by providing Islanders with an incentive to purchase electric vehicles.

The cost of the scheme (with regards to lost parking fee revenue) is incurred by the Car Park Trading Fund (CPTF). This fund is intended to cover operational and capital costs associated with the provision of public parking.

Since 29 August 2023 the public of Jersey have also had access to the Government Electric Vehicle Purchase Incentive (EVPI) scheme. Eligible individuals and businesses can apply for an incentive of 35% of the purchase value, up to a maximum of £3,500 towards the cost of an electric car or van.

#### **Discussion**

As technological advances occur, a higher proportion of private cars are qualifying for Eco-Permits (see table below). If the current trends continue the CPTF will be effectively subsidising parking for an ever increasing pool of vehicles.

Following engagement with Strategic Policy, Planning and Performance and the Minister for Environment it has been agree that the Eco-Permit Scheme and its benefits will in all likelihood be wound down at end of 2024 (i.e., Midnight 31st December) without alternative funding arrangements being found.

While the decision to extend the Eco-Permit scheme has in practice been taken on a year-by-year basis since its advent in 2008, nevertheless the 'Road Traffic (Public Parking Places) (Jersey) Order 2006' was not originally drafted on this basis and currently does not included an expiry date to the scheme or its benefits. Therefore, it is now necessary that the 'Road Traffic (Public Parking Places) (Jersey) Order 2006' is amended to include an expiry date (31st December 2024) such that while eligibility criteria for the permit will remain unchanged, the forward benefit through 2024 will decrease both in relation to newly registered 'electric vehicle' and 'plug in hybrid electric vehicle purchases' (i.e. those currently eligible for 12 full months of free parking) and those older vehicles eligible for half price parking. For example, a newly registered car bought at the beginning of July 2024 will only expect free parking for 6 months, etc.

In the eventuality that it is decided to extend the scheme beyond 2024 into 2025 this date would then be amended.

#### Recommendation

The Minister is recommended to incorporate, into the 'Road Traffic (Public Parking Places) (Jersey) Order 2006', an expiry date of 31st December 2024 to the Eco-Permit scheme and its benefits.

#### Reason(s) for Decisions

The increasing cost of the Eco-Permit Scheme cannot continue to be borne by the CPTF and the 'Road Traffic (Public Parking Places) (Jersey) Order 2006' should include an expiry date mechanism for limiting the onward benefit of the current permit scheme.
