### Purpose of the Report

I&E – Transport is proposing to carry out a Road Safety Improvements scheme on La Rue de Haut, near its junction with La Vallee de Saint. Pierre (St. Peters Valley), St. Lawrence to introduce a safer crossing point for pedestrians and school children walking along St. Peters Valley and accessing the neighbouring Bel Royal School.

The proposed scheme consists of;

- A raised table zebra crossing across La Rue de Haut Road adjacent to Bel Royal School.
- Improvements to the street lighting along La Rue de Haut.
- Improvements to northbound Bus Stop *Bel Royal School* (2387) on St. Peters Valley to allow for bus passengers to easier board and alight buses at this location.

It is intended to carry out this scheme in two phases with Phase 1 programmed to coincide with School Summer Holidays during July and August 2023 with further pedestrian improvements under a Phase 2 option which will be reviewed and implemented if feasible during the School Summer Holidays 2024.

With the support of the Road Works and Events Manager, and in line with the requirements of the Highways (Road Humps) (Jersey) Regulations 2002 and Road Traffic (Pedestrian Crossings) (Jersey) Order 1982, I&E Transport are requesting support for;

- An exemption from strict compliance with the Peak Time Restrictions policy. This will
  permit the appointed Contractor to carry out works on St. Peters Valley and La Rue
  de Haut, St. Lawrence (Appendix A General Arrangement) and would aid project
  completion whilst Bel Royal School are on their summer break.
- 2. Approval to install a road hump on La Rue de Haut, St. Lawrence.
- 3. Approval to install a zebra crossing on La Rue de Haut, St. Lawrence.

Traffic Order alterations to reduce the parking restrictions to a 3 hour limit along La Rue de Haut, adjacent to Clos du Val and reduce number of on-street parking spaces by 3 will form part of this scheme but will be approved under separate Ministerial Decision.

#### **General Information**

The works will be caried out under a Road Works Permit by I&E Transport authorised by the Highway Authority (I&E – Road Works and Events). All traffic and pedestrian management will be the responsibility of an External Contractor. All works would be carried out in accordance with the Code of Practice: 'Working Safely on Jersey Roads' 2020. Access to premises and a clear route for Emergency Service vehicles will be maintained at all times.

To minimise impact, all major stakeholders will be notified at least 6 weeks prior to works commencing, having already carried out comprehensive consolation with both the Parish and the Bel Royal School throughout the design stages.

The method of traffic control will be Temporary Traffic Signals on St. Peters Valley (A11) (where required) and a northbound/eastbound temporary one-way for traffic along La Rue de Haut from its junction with St. Peter's Valley to its junction with St. Aubin Inner Road (A1) (Appendix B- Traffic Management Plan) for the duration of the works.

#### Recommendation

- 3. The installation of a zebra crossing on La Rue de Haut, St. Lawrence
