## HEALTH INSURANCE (PHARMACEUTICAL BENEFIT) (GENERAL PROVISIONS) (No. 2) (AMENDMENT No. 11) (JERSEY) ORDER 2013

*1st October 2013*

**THE MINISTER FOR SOCIAL SECURITY**, in pursuance of Articles 15 and 36 of the Health Insurance (Jersey) Law 1967<sup>1</sup>, orders as follows –

### 1 Interpretation

In this Order, “principal Order” means the Health Insurance (Pharmaceutical Benefit) (General Provisions) (No. 2) (Jersey) Order 2002<sup>2</sup>.

### 2 Schedule 5 amended

In Schedule 5 to the principal Order, in the entry –

(a) in the column headed “Fee in pence for each item of pharmaceutical benefit supplied on a prescription”; and

(b) relating to item 1(b)(i),

for the amount “340” there shall be substituted the amount “345”.

### 3 Schedule 6 amended

For the table in Schedule 6 to the principal Order there shall be substituted the following table –
