## Introduction

The previous Minister for Social Security established the Cost of Living Temporary Scheme (COLTS) via Ministerial Decision (MD-SOSEC-2022-308) on 26<sup>th</sup> April 2022. The scheme paid £20 per person, per household to people claiming any of the following benefits – Income Support, Community Costs Bonus, Cold Weather Bonus and Pension Plus.

In light of the rising cost of living being seen by Islanders, and as part cost of living support "mini-budget" proposed by the Chief Minister and Council of Ministers, it has been decided to increase the value of COLTS payments for a period of 5 months i.e. until the scheme ends in December 2022.

All other aspects of the scheme will remain the same and the published policy guidelines will be updated to reflect the change in payment value.

## Detail (Decision and Reason for decision)

Following agreement from the Council of Ministers, the Minister for Social Security has decided to increase the COLTS payment value (per person, per household) from £20 to £40, effective from the August payment run.

The initial estimated spend for COLTS was  $\pounds 2$  million. This increase in payment value will see the estimated cost rise for 5 of the 9 months the scheme will be live. The estimated additional spend is  $\pounds 1.1$  million, this additional funding will be drawn from existing CLS income support and tax funded departmental budgets.
