Introduction

Further to Article 15, paragraphs (11) and (12), of the Health Insurance (Jersey) Law 1967, and having consulted with the Pharmaceutical Benefit Advisory Committee, the Minister decided to make amendments to the Prescribed List with effect from 1 May 2025.

The Minister accepted recommendations from the PBAC in respect of the following additions and deletions.

1. Additions

Office Minnistéthielle

- Melatonin 1mg, 2mg, 3mg, 4mg, 5mg tablets for children and adolescents aged 6-17 with ADHD-related insomnia
- Hydrocortisone 2.5mg, 5mg tablets for replacement therapy in patients with adrenocortical insufficiency (additional strengths; 10mg strength already on Prescribed List)
- Ibuprofen 200mg orodispersible tablets and Ibuprofen 200mg/5ml oral suspension sugar free non-steroidal anti-inflammatory for mild/moderate pain
- Morphine sulphate orodispersible tablets 1mg, 2.5mg, 5mg, 10mg, 20mg, 30mg (Actimorph brand) for moderate/severe pain
- Latanoprost 50micrograms/ml / Netarsudil 200micrograms/ml eye drops for previously treated primary open-angle glaucoma or ocular hypertension in adults
- Ciclosporin 1mg/ml eye drops 0.3ml unit dose for severe keratitis in adult patients with dry eye disease, which has not improved despite treatment with tear substitutes

- Estradiol 1mg/progesterone 100mg soft capsules (containing 17β estradiol 1 mg plus micronised progesterone 100 mg) (Bijuve brand) for oestrogen deficiency symptoms in postmenopausal women with intact uterus
- Ospemifene 60mg tablets for moderate to severe symptomatic vulvar and vaginal atrophy [in post-menopausal women who are not candidates for local vaginal oestrogen therapy]
- Estradiol (as Estradiol hemihydrate) 1 mg, Norethisterone acetate 500 microgram,
 Relugolix 40 mg tablets (Ryego brand) for moderate to severe uterine fibroids
