#### Introduction

Inspectors within the Health & Safety Inspectorate (HSI) are authorised in writing by the Minister for Social Security for the purposes of Article 12, 13, 14 and 15 of the Health & Safety at Work (Jersey) Law 1989 and Article 4 of the Employers Liability (Compulsory Insurance) (Jersey) Law 1973

### **Authorisation of Inspector**

The written authorisation is made in an electronically produced 'credit card' style warrant card, which outlines the powers authorised and contains a photo of the Inspector, their signature and the Minister's signature.

A request is made to the Minister for written authorisation of each individual Inspector as they join HSI, and an electronic signature is provided in each case for the card.

Following an open recruitment campaign JILLIAN GANNON will join HSI as an Inspector on 16 June 2025.
