

I appreciate you intentions, Ideally yes a collective view of States members would be helpful and if a debate had happened in the States already then the outcome could have been considered during the inquiry. But this debate is being held after the inquiry and after the inspector report .

So the problem with your suggestion is that members will need to have access to the inspectors report to make the political judgment as to whether the public interest overrides the planning balance judged against the IP as concluded by the Inspector. The law unequivocally requires me to make a decision before the inspectors report is published and for me to avoid doing so would re-open the whole matter and undermine the Inquiry process in the public eye. The process is intended to give a binary decision

I am clear that if the inspectors recommendation were overode there would be a challenge and maybe in the Court by way of JR which I would guess lead to many months delay . The system needs a clear decision . In making it I want it to be clear that my decision is in respect of an application and not the site . The way remains open for a revised application which avoids the planning damage reported by the inspector.

Dear John.

One final suggestion and piece of advice from me before the final button is pushed which I would like you to consider please.

I say this as a result of further thought overnight and also further to the Health Ministers position again stated today in the JEP. I also say this with me taking a more strategic government position, as opposed to my specific planning role, which I can't ignore.

This is the biggest decision that the planning system will have been asked to deliver in recent memory, and arguably the biggest ever given to the SoJ. Therefore, I feel there is an argument for a slight variation in process.

I agree that you need to make clear the planning issues with the current application and the challenges this specific application has.

One thought, you could be open and clear that you are "minded to refuse", and to list and show your reasons on Monday. There is no reason why this can't be public and shared.

I am very troubled about the public interest test and the impact this decision will have on the scheme. I think there is a high risk it is stopped dead and the spend and work to date is lost completely. If this happens, we lose the opportunity to do further work to deliver the much needed hospital. The realistic prospect of it being delivered elsewhere in my view is zero. This is not a good outcome for anyone.

In making the "minded to" position clear, you can be very open about your position, about your view as Minster and the view you carried into the election, and release the report. You could then use the States debate pursuant to the CM's proposition to provide you with a clear public interest response. You could be clear that is what you intend and a proposition could even be worded that way. You will take the mood of the assembly, and then make the decision as planning minister on the application before you. The assembly is purely about public interest and not the planning application.

Whilst as officers we are clear on the public interest case to approve, this approach protects you as Minister as I think it is an impossible ask to assess the public interest without all public elected representatives inputting. After all that is the function of elected members.

It also protects the end aim which ultimately everyone agrees with. If the assembly go against, then fair enough you are doubly clear on both.

Can I ask you to consider this approach, as once we push the button we cannot retrieve.
