Minutes. A1. The Minutes of the meetings of the Council of Ministers of 21st February, 7th and 14th March (Parts A and B) and 17th March 2023 (Part A only) having previously been circulated, were taken as read and were confirmed.

Forthcoming A2. The Council of Ministers discussed the following items of public business which were scheduled to be debated by the States Assembly at the meeting that was due to commence on 18th April 2023 –

**Draft Endangered Species (CITES) (Amendment) (Jersey) Law 202-** (P.8/2023) The Council noted that this Proposition, which had been lodged '*au Greffe*' by Deputy J. Renouf of St. Brelade, Minister for the Environment, sought to amend the Endangered Species (CITES) (Jersey) Law 2012 ('the Law') by, *inter alia*, altering the definition of Appendices 1, 2 and 3 in Article 2 of the Law to refer to the corresponding Appendices to the Convention on International Trade in Endangered Species ('CITES'), rather than having to list the content of the Appendices in the Schedule to the Law. This would ensure that the Law always reflected the current position in the CITES.

It was recalled that CITES provided varying levels of protection for species of animal that were at risk from extinction or over exploitation;

### Channel Islands Lottery Distribution of Proceeds (P.10/2023)

This Proposition, which had been lodged by Deputy K.F. Morel of St. John, St. Lawrence and Trinity, Minister for Economic Development, Tourism, Sport and Culture, requested the States Assembly to agree to allocate £633,458, being the net proceeds from Jersey sale of lottery tickets in 2022, equally to the Jersey Community Foundation and the Association of Jersey Charities. It was recalled that this accorded with the provisions of Regulation 4(5) of the Gambling (Channel Islands Lottery) (Jersey) Regulations 1975.

It was noted that the proceeds allocated to the Association of Jersey Charities should only be distributed to registered charities locally and that, of the allocation to the Jersey Community Foundation, 40 per cent would be distributed to arts, culture and 196 28th Meeting 28.03.2023

heritage; 40 per cent to sports and active lifestyle and 20 per cent to applied science or research in various fields of science either locally or of direct benefit to Jersey;

# Land Transaction under Standing Order 168(3) – Andium Homes Ltd Site, Kensington Place – sale to the public: deferral of approval (P.11/2023)

The Council of Ministers noted that this Proposition, which had been lodged by Deputy L.J. Farnham of St. Mary, St. Ouen and St. Peter, requested the Minister for Infrastructure to defer the approval of the land transaction agreement, as proposed in R.33/2023, until such time as the States Assembly had considered the costs and clinical outcomes for health care provision over several sites.

The Council recalled that the Government Plan had included a new head of expenditure of  $\pm 51.5$  million for work on healthcare facilities during 2023, of which  $\pm 16$  million had been allocated for the strategic acquisition of a site in Kensington Place, which had been purchased in December 2021 by Andium Homes.

Ministers were cognisant that, under Standing Order 168(3) the Minister for Infrastructure was required to provide at least 15 working days' notice of various actions relating to transactions in land, including the acquisition, disposal, letting or rental of land on behalf of the public of Jersey. R.33/2023, which set out the intention to acquire the Andium Homes site had been presented to the Assembly on 1st March and the Proposition of Deputy Farnham had been lodged on 17th March, which was within the requisite timeframe.
