Our Stars awards.

A1. The Council of Ministers noted that the *Jersey Evening Post* of 26th September 2023 included an article relating to the public sector Our Stars Awards. The event had been attended by several Ministers and there had been in excess of 1,700 nominations. It was agreed that all nominees could be very proud of themselves and the wide breadth of services provided by Government was noted.

Forthcoming business.

A2. The Council of Ministers discussed the following items of public business which were due to be debated by the States Assembly at the meeting that was scheduled to commence on 3rd October 2023 –

<u>Draft Register of Names and Addresses (Amendment) (Jersey) Law 202-</u> (P.56/2023)

The Council agreed to support this Proposition, which had been lodged by the Chief Minister and would amend the Register of Names and Addresses (Jersey) Law 2012 to permit the Chief Minister to supply certain information about Jersey residents from the register of names and addresses to credit reference agencies with a view to resolving the current issues that some Islanders were facing in accessing credit card services. The information would be gleaned from a system entitled *Populus*, which collated the data from a register maintained by the Customer and Local Services Department and information provided online by people registering to move to the Island;

Draft Employment (Amendment No. 14) (Jersey) Law 202- (P.62/2023)

It was recalled that the United Kingdom had introduced 'Jack's Law' in 2020 to guarantee working parents time off following the death of a child. Deputy S.M. Ahier of St. Helier North had brought forward a Proposition (P.70/2021 referred) to introduce similar rights locally and this had been adopted by the States Assembly. The current Proposition would make changes to the Employment (Jersey) Law 2003 to provide for statutory unpaid leave entitlement of 2 weeks following the death of a child under the age of 18 years. The leave could be taken in up to 3 separate periods up to 56 weeks from the date of death. It was noted that Deputy Ahier and the relevant Scrutiny Panel were supportive of the Proposition.

Welcome – officer from the United Kingdom Civil Service Fast Stream.

A3. The Council of Ministers welcomed a participant in the United Kingdom ('UK') Civil Service Fast Stream to part of the meeting and was informed that he had been in the Island for a period of 6 months on secondment working with the Strategic Policy, Planning and Performance Department. It was noted that he had been working with officers from the Justice and Home Affairs Department on the criminal injuries compensation scheme.

Ministers expressed the hope that he had enjoyed his time in Jersey and suggested that there should be more opportunities for such exchanges between the UK Civil Service and Jersey Government.
