Covid-19: Stay at Home instruction. A1. The Council, having regard to the latest clinical advice and following a period of extensive preparation, endorsed the recommendation of the Minister for Health and Social Services, having received the advice of the Medical Officer for Health, to implement a Stay at Home instruction, applicable to every individual in Jersey, unless undertaking essential work or otherwise in accordance with the agreed guidance, with effect from 8 a.m. on Monday 30th March 2020. It was noted that guidance would be published, in order to assist Islanders in complying with the instruction.

The Council was satisfied that this was a necessary measure, designed to slow the Covid-19 pandemic within the Island.
