States of Jersey Police and Diana Awards -Mentoring Programme. A1. The Council, with the Director General for Justice and Home Affairs, Chief Inspector M. Hafey of the States of Jersey Police (SOJP) and Mr. T.M. Hughes in attendance, was briefed on the Diana Award Mentoring Programme for Jersey.

The Director General introduced Mr. Hughes, who had been a recipient of a Diana Award, in recognition of his work with the St. John Ambulance Service.

Mr. Hughes explained that the Diana Award programme had been established as a charitable legacy to Diana, Princess of Wales, and aimed to develop and inspire positive change in the lives of young people. The Mentoring Programme for Jersey (which followed a model used successfully in Birmingham, Leeds and London) would involve SOJP Officers mentoring 12 young people, between the ages of 13 and 16, who were not currently engaged in education, employment or training.

The Council was informed that young people who grew up without a positive role model in their lives were 67 per cent less likely than their peers to gain employment when leaving education. The programme aimed to reduce this statistic and provide young people with the support and skills needed to enter employment or post-16 education. Over a 10-month period the Mentees would gain life skills as well as an insight into the world of employment and, together with their Mentors, would participate in social projects or campaigns which affected their own community.

The Programme was due to launch on 21st October 2019 and would run until July 2020; funding had been provided by HSBC for 2 years and the Council was advised that the second year of the project would involve the Jersey Fire and Rescue Service and the Jersey Ambulance Service in addition to the SOJP. Overall it was anticipated that 40 young people would participate.

The Council agreed that the Programme could potentially improve relationships between the SOJP and vulnerable young people in the Island and would reinforce the commitment of the SOJP to the Young People's Pledge. The Council thanked Mr. Hughes for his presentation and confirmed its support for the programme.
