Minutes.

A1. The Minutes of the meetings of 18th September and 2nd October 2019 (Part A and Part B) having previously been circulated, were taken as read and were confirmed.

Matters arising from previous Minutes.

A2. The Council, with reference to its Minute No. A2 of 18th September 2019, was advised by the Minister for International Development, Deputy C.F. Labey of Grouville, that she wished to record her dissent to the adoption of the International Holocaust Remembrance Alliance definition of antisemitism.

The Council noted the position accordingly.

States Business, 12th November 2019. A3. The Council, with reference to its Minute No. B1 of 16th October 2019, discussed with the Head of Ministerial Support, Office of the Chief Executive, the list of public business scheduled for consideration by the States Assembly on 12th November 2019 and commented specifically on the following:

## States Assembly: time limits on speeches in debates (P.101/2019)

The Council recalled that the Privileges and Procedures Committee (PPC) sought to introduce amendments to the Standing Orders of the States of Jersey, limiting the time that Members were permitted to speak on a proposition to 15 minutes, albeit that the proposition also called for the Presiding Officer to be allowed to exercise discretion in certain circumstances.

Senator S.Y. Mézec, Minister for Children and Housing and Deputy J.H. Young of St. Brelade, Minister for the Environment, advised that they would not be supporting the proposition, which they considered undemocratic;

## Channel Islands Lottery: allocation of proceeds from 2018 (P.105/2019)

The Council was advised that the proposition replaced the previously-withdrawn P.87/2019, which had advocated the appointment of a U.K. organisation to administer the system for distributing lottery proceeds. Following feedback received from a number of sources, the Minister for Economic Development, Tourism, Sport and Culture, Senator L.J. Farnham, had decided not to proceed with the appointment of an external contractor and had asked officers to identify an alternative solution, making use of local expertise if available.

The Council was advised that the proposition represented a short-term solution, which would use the existing service level agreement with the Association of Jersey Charities to disburse £1,000,000 of the proceeds from the 2018 Channel Islands Lottery to charitable causes in Jersey, until a permanent solution had been identified;

# States of Jersey Development Company Limited: re-appointment of Non-Executive Directors (P.108/2019)

The Council noted that the Minister for Treasury and Resources, Deputy S.J. Pinel of St. Clement, sought the approval of the States to reappoint 2 Non-Executive Directors of the States of Jersey Development Company (SOJDC) for a further term of 3 years each.

The Council supported the proposed reappointments and was advised that the Jersey Appointments Commission (JAC) had been consulted as part of the process. The Chief Executive advised that the JAC was involved in all recruitment to arms-length bodies such as the SOJDC and had issued guidance on process, diversity and pay for Non-Executive Directors. The JAC was also in the process of reviewing the

memoranda of association with various arms-length bodies and its semi-annual report to the States Employment Board would also be presented to the Council in due course.
