A3. The Council, with reference to Minute No. A1 of 28th March 2018 of the Council as previously constituted, discussed with the Director - Corporate Policy, Chief Minister's Department, the list of public business scheduled for consideration by the States Assembly on 26th June and 10th July 2018 and commented specifically on the following:

# Ratification of the Agreement and Exchange of Letters for the Exchange of Information relating to tax matters between the Government of Jersey and the Kingdom of Spain (P.60/2018)

The Council noted that the Minister for External Relations sought ratification by the Assembly of the Tax Information Exchange Agreement which had been signed on 17th November 2015 (the Agreement) and the subsequent letters exchanged between the Government of Jersey and the Government of the Kingdom of Spain (the Letters) clarifying the definition of the geographical area of the Kingdom of Spain. Having clarified the position regarding the geographical definition, the Council noted that the Agreement (with the Letters appended thereto) would be published and entered into the official record. The Council recognised that the Agreement accorded with the States of Jersey's declared policy of compliance with international standards on transparency and the exchange of tax information and therefore decided to support the proposition.

### Pedestrian Crossing outside La Moye Primary School: Petition (P.61/2018)

The Council noted that Deputy M. Tadier of St. Brelade sought the approval of the Assembly to request the Minister for Infrastructure to ensure the installation of a pedestrian crossing outside the entrance to La Moye School before 1st September 2018. An amendment had been lodged by the Minister for Infrastructure to extend the deadline to 1st September 2019, given that a full programme of work already existed for 2018, a crossing attendant operated daily during school start and finish times and the Minister could offer no justification for escalating the installation of this particular crossing above others already planned for 2018. The Council accordingly agreed that the proposition, as amended, should be supported. The Council acknowledged that road safety in general was an issue of public concern and also agreed that consideration should be given in due course to streamlining the process by ring-fencing a portion of the capital budget for small works to be carried out in conjunction with the parishes, as part of a wider discussion on the States' capital expenditure programme.

## Jersey Police Complaints Authority: appointment of Member (P.80/2018)

The Council noted that the Minister for Home Affairs sought the approval of the Assembly to appoint Mr. G. Jennings as a member of the Jersey Police Complaints Authority (JPCA) for a period of 3 years beginning 2nd July 2018. Having considered Mr. Jennings' relevant skills and experience, as well as details of the appointment process undertaken, the Council agreed that the proposition should be supported.

## **Draft Referendum (Presidency of the States Assembly) (Jersey) Act 201-** (P.76/2018)

The Council noted that the Privileges and Procedures Committee had lodged the draft Act pursuant to the decision of the Assembly on 16th November 2017 to adopt P.84/2017 – 'Elected Speaker and Deputy Speaker of the States Assembly: selection and appointment' in order that a referendum could be held (as provided for in the proposition) in accordance with the Referendum (Jersey) Law 2017. Connétable C.H. Taylor of St. John informed the Council that the Comité des Connétables would be lodging an amendment in due course as it had concerns regarding the proposal to hold the referendum on a Saturday. Senator S.Y. Mézec suggested that any recommendations contained in the report of the Election Observation Mission of the Commonwealth Parliamentary Association (the final version of which had yet to be

published although a preliminary report had been issued) following the May 2018 Election should be taken into account. The Greffier of the States reminded the Council that the Assembly had agreed (subject to the outcome of a referendum) that a Speaker should be elected prior to the first sitting of 2019 and advised that the proposition would therefore need to be debated before the summer recess. The Council noted the time pressures but agreed that more time was need to properly consider the matter and accordingly decided to defer consideration of the Act until the States sitting of 10th July 2018.

# La Route de St. Aubin: installation of pedestrian crossings and reduction of speed limit (P.68/2018)

The Council was informed that Deputy M.R. Higgins of St. Helier had confirmed his intention to withdraw the proposition.

### Future Hospital: Public Inquiry – Terms of Reference (P.90/2018)

The Council was advised that agreement had been received from the proposer, Deputy R. Labey of St. Helier, to defer consideration of this proposition until the sitting of 10th July 2018.

## **Draft Financial Services Commission (Amendment No. 7) (Jersey) Law 201-** (P.74/2018)

At the request of the Minister for External Relations, the Council agreed that the proposition should be considered on 26th June 2018.

Items to note.

- A4. The Council received the following updates:
- (1) the Chief Executive confirmed that a copy of a report prepared for the States Employment Board by HR Lounge concerning Bullying and Harassment within the States of Jersey would be circulated to Ministers. The Council noted that the report had been made public following a Freedom of Information request; and
- (2) the Chief Executive also advised that the Council would be briefed shortly on the recently completed Ofsted review into the Children's Service.
