Health Certificate to export pet birds to a Third Country

Application for an official export certificate for pet birds to a Third Country

Some Third Countries require pet birds to have an export health certificate ('EHC') to enter. It is the owners/exporters responsibility to adhere to any requirements laid down by the country you are importing to, although the department will endeavour to help you wherever possible. You will need to ensure that you find out from the authorities of the country you are travelling to, if they will accept an EHC issued in Jersey, which is part of the British Isles and has the same import requirements as the United Kingdom.

It is the responsibility of the owner/exporter to ensure that an import permit or licence (if applicable) has been applied for from the authorities of the country to which the bird(s) are to be exported.

It is also the owners/exporters responsibility to obtain a CITES application form from the department if the bird(s) are specified under the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES). For a full explanation about CITES, and for specific identification see www.cites.org

The EHC will be signed by your Veterinary Surgeon who must be authorised by the department. Please note that any fees charged by your Veterinary Surgeon are a private matter between the Vet and yourself.

Please allow at least 20 working days for processing.
