Application for a licence to import sheep and goats to Jersey (From the UK, IOM and Cl's)

You must obtain your Isolation Premises Approval Certificate, which is issued by the States Veterinary Officer, before a licence may be issued.

A person importing sheep and goats under the Animal Health (Importation of Miscellaneous Goods and Animals) (Jersey) Order 2017, article 3 must be in possession of a licence granted by the Minister, or a person who has been appointed by the Minister, to import into Jersey.

We recommend that your supplier confirms that there are no restrictions imposed by a competent authority for any diseases and that they are able to meet the requirements set out within the health certificate and guidance notes. Copies of these are on our website www.gov.je
