Technical guidance notes.

Detailed guidance on meeting the building bye-law requirements for replacement windows, doors and rooflights be found in the Approved Document 11.1B (2016 Edition), copies of which can be downloaded from the States of Jersey website, www.gov.je, or purchased from the department.

Cavity Barriers Requirements – A 30 minute cavity barrier should be provided if replacing timber framed wind plastic or metal framed windows.

Safety Glazing Requirements – Safety glazing is required in the following locations:

- In a window which is less than 800mm from finished floor level
- In a door that has glazing below 1500mm from finished floor level
- In a window located within 300mm of a door to a height of 1500mm above finished floor level

Ventilation Requirements – Total openable area of all units in the room should not be less than 1/20th of the fluor of the room.

U-values Requirements – U-values can be obtained from Technical Guidance Document 11.1B Conservation Fuel and Power in existing dwellings (2016 Edition).

Background Ventilation – Where background ventilation previously existed the same level of provision must b made in the new window.

Escape Windows – All habitable rooms on the first floor, and inner rooms on the ground floor should have eme egress windows with no dimension less than 450mm and providing a clear opening size equal to 0.33sqm wher these previously existed. *Example of an area weighted U-value calculation:* Total rate of heat loss / total area gi average U-value.
