# **ENFORCEMENT NOTICE**Planning & Building (Jersey) Law 2002

THIS NOTICE TAKES IMMEDIATE EFFECT ON THE DATE IT IS ISSUED

#### 1 This Notice:

Is issued pursuant to the powers conferred under Article 40 of the Planning and Building (Jersey) Law 2002 because it appears that a breach of development controls has occurred at the Land stated below. Article 5 of the above Law defines the meaning of development and Article 7 of that Law states that Land shall not be developed without planning permission.

#### 2 This Notice relates to land at:

Les Chevaux Blancs, 2 Zeelandia, Le Mont a la Brune, St. Peter, JE3 7FL (edged in RED on the attached 'Enforcement Notice Location Map')

#### 3 The Matters which appear to constitute the Breach of Development Controls:

Without Planning Permission development has occurred at Les Chevaux Blancs, 2 Zeelandia, Le Mont a la Brune, St. Peter, JE3 7FL namely;

3.1 At the southern boundary of Les Chevaux Blancs, 2 Zeelandia, Le Mont a la Brune, St. Peter, JE3 7FL that boarders Le Mont a la Brune, a wooden panel fence has been erected without prior planning consent. The fence amounts to development, as defined in Article 5 of the Planning and Building (Jersey) Law 2002 and is not granted permission by way of the provisions of the Planning and Building (General Development) (Jersey) Order 2011.

#### 4 Reasons for Issuing this Notice:

4.1 It appears that the Breaches of Development Controls have occurred within the last 8 years.

#### IMPORTANT – THIS COMMUNICATION AFFECTS YOUR PROPERTY OR INTEREST

4.2 The fence located on the southern boundary of Les Chevaux Blancs, 2 Zeelandia, Le Mont a la Brune, St. Peter, JE3 7FL by virtue of its size, design and siting would be dominant and intrusive in the rural landscape and therefore harmful to the landscape character of the area, contrary to Policies GD1, GD7 and NE7 of the Adopted Island Plan, 2011 (Revised 2014)

#### 5 Steps Required to Rectify the Breach:

Remove the unauthorised development and restore the land to a condition comparable to that prior to undertaking the unauthorised works by;

#### Step 1

Removing the wooden fencing and any associated footings or posts located at the southern boundary of Les Chevaux Blancs, 2 Zeelandia, Le Mont a la Brune, St. Peter, JE3 7FL that boarders Le Mont a la Brune.
