Section C – Requirements of registration

In order to register as a Motor Vehicle Removal Operator, you need to satisfy the Minister for Justice and Home Affairs that:

(a) You have sufficiently secure premises to store any motor vehicle removed from private land;

Please provide information on the premises you will use to store vehicles, including the address of the premises; and security facilities (e.g. fencing; gate and access control).

If you are registering as a motor vehicle removal operator only, and do not intend to store any vehicles that you remove from private land, please provide information about the arrangements you have in place to remove vehicles to a secure location, including the name and the address of the person it is administered by.
(b) You have a vehicle(s) that is suitable for the safe removal of a vehicle from private land
Please provide details of the removal vehicles you own and operate and a description of the associated equipment that will be used to remove vehicles from private land.
(c) If registered, you will have adequate insurance against any loss or damage to a motor vehicle in your custody.
Please provide information on the insurance cover you hold.

Motor Vehicle Removal Operator Registration

As a 'controller' under the Data Protection (Jersey) Law 2018 we process and hold your information in order to provide public services and meet our statutory obligations. We may not be able to provide you with a service unless we have enough information or your permission to use that information. Below, we explain what we collect; how we will use your information; and what your rights are.

We have collected your personal details (name; address, contact details and signature) and we do this in order to register you and/or your organisation as a motor vehicle removal operator; to ensure that we meet our legal obligations; to allow the statistical analysis of data so we can plan the provision of services; and where necessary, for our law enforcement functions; or to protect individuals from harm or injury.

We will endeavour to keep your information accurate and up to date although we rely on you to inform us of any changes in accordance with the Motor Vehicles (Removal from Private Land) (Jersey) Regulations 2019. We do not keep it for longer than is necessary. Please see our published retention schedules for more detail about how long we retain your information. We will not pass any personal data on to anyone outside of the States of Jersey, other than those who either process information on our behalf, or because of a legal requirement, and we will only do so, where possible, after we have ensured that sufficient steps have been taken by the recipient to protect your personal data.

There is a legal requirement under Regulation 7 of the Motor Vehicles (Removal from Private Land) (Jersey) Regulations 2019 for the Minister for Home Affairs to prepare and make available a public register of motor vehicle removal operators. If you and/or your organisation is successfully registered as a removal operator, the following information will appear in the register:

- The name and address of the motor vehicle removal operator
- Telephone number
- The activities to which registration applies
- The premises to where vehicles will be removed
- The contact information for the release of removed vehicles

You can ask us: to stop processing your information; to correct or amend your information; for a copy of the information we hold about you. You can also: request that the processing of your personal data is restricted; and withdraw your consent to the processing of your information.
