**Introduction**

A planning application for works to convert St Ouen's Methodist Church to an indoor Skate Park for the charity Skate Space has been received. The applicant requests a 50% reduction of the fee paid due to the charitable nature of the business. This amounts to a loss of income of £1,839.60. This is in line with other charities which have received a 50% fee reduction from the Minister in the past.
